# Q 1 Please summarize the main findings of the study.

This study addresses the areas of economics and mental heath, particularly the effects of COVID-19 pandemic in both areas, and how them relate, based on a survey developed in Chile.

Results indicate 1. Unemployment and income loss as highly predictive of experiencing lack of savings, difficulties paying bills, debt, and mortgage loans. 2. Financial distress leads to a higher prevalence of poor well-being and mental health deterioration.

These results are not surprising and have been discussed in the mental health area and in public health especificly

through social determinant perspectives, but its uniqueness underlies in the expert economist expert point of view, wich must be highlighted as an effort for the much desired intersectoriality in public health issues.

#### Q 2 Please highlight the limitations and strengths.

The strengths are the following:

- Provides evidence on a subjec that needs to be urgently and sostenaibly adressed by public policy
- Gives a fresh point of view in the analysis of mental health and COVID-19, that is not only based on the risks of contagion or lockdown
- It adresses a key point on people daily life: Work and income (as the paper states, one of the main stresors for people) and it does it with general population. This is a strength for me, because on the area I develope work is mainly adressed regarding discrimination and stigma against people that has been diagnosed, and the barriers in finding and mainteining a job.
- Linked with that, it builds attention on the fact that mental health is a dynamic quality, more than a permanent condition, and its affected by our environment, is not just an individual experience based on biological marks.

Regarding limitations, I will discuss, from my perspective and area of knowledge:

- The paper doesn't seem to adress social issues like social and economical inequality
- There is a need for social determinants of health approach
- It would be desireable a more on depth link with Chilean reality and its description, for a more situated reading
- There's and overall necesity for more problematization and critical discussion of the subjecs arrised
- I would recommend the use of more latin american based data

As a non-expert in quantitative methodology, there are many thing that scape my expert opinion, but I find this paper and its results useful as evidence for many possible research projects and social interventions in Chile.

That been said, the main points I believe would have help for a more deepen understanding of the methodology are the characterization of the sample (and again, also to paint a picture regarding the reality of the country), and to clarify the variables in the tables, adding notes to each with their meaning to promote a better understanding for the reader, same with columns.

Both conclusions, about expansion of mental health services and financial education could be deepened through concrete recommendations based on the findings, as well as on the possibilities and limitations of the Chilean context, in order to guide its implementation.

Furthermore, discussion regarding access to treatment should be enhanced with evidence and national references, since it does'nt adress mental health public policy, services network or concrete areas that need work.

Besides, from a social sciences point of view in public mental health, it makes more sense that -if the need is related to financial and work distress- the recommendations point to ensure benefits and better work and financial conditions, which is the main issue and the origin of the subjective suffering, which involves a public responde, more than an individual treatment of the symptoms this issues have for a person. Not mentioning the also increased use of antidepressants, self-medicated and provided from the basis of the MH services in primary care and so on, during pandemic.

I would suggest to make a more profound dialogue between economics, public health and mental health, with a situated approach of these.
