- 1- Clarify the search strategy by specifying the inclusion/exclusion criteria, search terms, and how data were selected and analyzed to improve replicability and applicability.
- 2- Include a quality assessment of the included sources to ensure rigour and strengthen the credibility of the findings.
- 3- Enhance data visualization by adding a line graph or other visual representation to complement Table 1 and better illustrate mortality trends.
- 4- Expand the discussion to explore the underlying causes of poor-quality care and address regional variations or disparities where these issues are more pronounced.
- 5- Propose more evidence-based solutions or actionable recommendations for policymakers to address the dual challenges of healthcare access and quality.
